Our **Data Cloud** hosted through Snowflake® provides direct integration with a data marketplace so asset management teams can query their Archer datasets alongside proprietary and third-party data. Managers can schedule queries to suit their needs and use available apps to quickly view data subsets and data visualizations. This approach is best for managers who wish to directly query a database for the greatest amount of flexibility in the combination of what and how information can be obtained.

**File Transfer** makes select standardized data sets available via secure file delivery, providing managers the ability to schedule loading large amounts of data to their data warehouse for internal integration, reporting, and formatting for downstream use. Deliveries may be scheduled to align with your business practices and processes. This option is **best for asset managers that are looking for a scheduled flat-file delivery of datasets.** 

#### TARGETED DATA ACCESS

The **Download Center** provides on-demand access to focused reporting of data sets, including accounts, assets, transactions, performance, and compliance. It includes onscreen viewing and filtering capabilities and enables users to modify reports, save them for future use, and perform ad-hoc analysis in Excel. The Download Center provides quick access to recent history data for limited accounts and filters to target specific information on individual reports.
